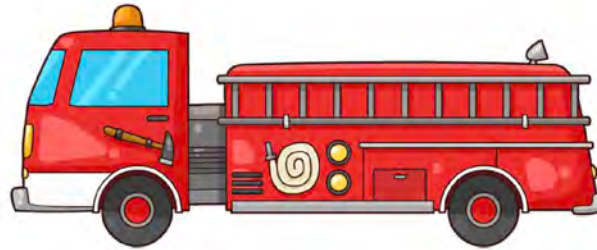


# “Pullin’ for Partnership”

## Fire Truck Challenge 2022 Team Kit



Attention Team Captains!

*Do you have what it takes to pull a 46,000-pound fire truck?* Teams will compete for bragging rights and a chance to prove their strength on Tuesday, Oct. 25, 2022, rain or shine.

This is the second annual "Pullin' for Partnership" Fire Truck Challenge, which will help Partnership for a Drug-Free Community keep our programs rolling.

Teams of 10 will compete to see who is fastest at pulling the fire truck a length of 100 feet — twice the length of last year's pull. Last year's fastest time was 10:15 seconds; the slowest was 15:62 seconds. This is a fun, fast-moving event you'll never forget!

All proceeds raised during the event will go directly to Partnership for a Drug-Free Community programs and services. This year, team pledges, sponsorships, and donations are more important than ever. All proceeds are tax deductible.

Among its programs, Partnership provides prevention and education services for youth in grades 2-12 with the Ozzie Opioid Prevention Programs (Ozzie OPPs). For grades 5-12, college students, and even parents, the Youth Tobacco & Vaping Prevention Program provides a prevention and education curriculum, based on Stanford University Medical School's Tobacco Prevention Toolkit. The agency also provides recovery resources to anyone with a substance use disorder, along with the family and friends who care about them. The Hub provides an impartial one-stop shop for treatment options and referrals. All Partnership programs and services are free.

Enclosed are registration forms for your team members, pledge sheets, event rules, waiver forms and team photo releases (to be filled out and signed by each team member).

# “Pullin’ for Partnership”

## Event Rules

- Sponsorships or \$250 registration fee must be submitted by Friday, Sept. 30, 2022. Team rosters should be submitted no later than Friday, Oct. 7, 2022. Waivers and photo releases to be signed on site.
- All funds raised must be turned in by the date of the event to determine the top fundraising team.
- The fire truck pull will take place, rain or shine.
- Team start times will be assigned once all teams are registered.
- No more than 10 members are allowed per team. Any person without a signed waiver will not be eligible to participate.
- Participants must be at least 16 years of age. Participants under 18 require a parent or legal guardian to sign their waiver.
- Team captains are responsible for having their team ready 15 minutes prior to their scheduled pull time.
- Each team will be allowed only one pull.
- Attachments or extensions to the rope provided are prohibited.
- Teams may remove slack but must not begin pulling until signaled.
- All team members must be behind the painted line of the rope.
- The signal to begin the pull is “Ready, Set” and the blowing of a horn. Once the horn blows, the timer begins.
- After 5 minutes, if your team has not pulled the fire truck across the finish line, the team will be disqualified.
- A referee will signal with a flag when the truck has crossed the finish line and timing will stop. All team members must drop the rope at the sound of the whistle.
- Each team’s pull time will be determined and recorded by the time keeper’s stop watch. The ruling of the referee stands.
- Pull times will be listed on a scoreboard near the team area.
- Should there be a tie for fastest pull, there will be a drawing to determine the winner.
- Participants are encouraged to bring their own gloves.
- Closed-toe shoes are required; no sandals permitted.
- Immediately following each team’s pull, the team will assemble on the side of the fire truck for a team photo. Team photo will be emailed to the team captain.
- Winners will be announced immediately at the end of the competition.

## WAIVER OF LIABILITY, ASSUMPTION OF RISK and INDEMNITY AGREEMENT

In consideration of participating in Partnership for a Drug-Free Community's, “Pullin’ for Partnership” Fire Truck Challenge Event (hereinafter “the Event”), I declare that I am aware of and understand the nature of the Event and that, in order to participate, I am qualified, in good health, in proper physical condition, and NOT UNDER THE INFLUENCE OF ANY CONTROLLED SUBSTANCE. I also agree that if I believe the conditions surrounding the Event are unsafe, I will immediately discontinue participation in the Event.

I fully understand that the Event involves risks of serious bodily injury, including disability, paralysis and death, which may be caused by my own actions or inaction or those of others participating in the Event, the conditions in which the Event takes place or the negligence of the “Releasee” named below and that there may be other risks either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and responsibility for losses, costs, and damages I may incur as a result of my participation in the Event. I hereby release and discharge Partnership for a Drug-Free Community, Inc., the City of Madison and its agents and employees, the Madison Board of Education and their administrators and employees, directors, agents, officers, volunteers, other participants, any sponsors, advertisers and any owners and lessors of the property on which the Event takes place from any liability, claims, demands, losses or damage caused or alleged to cause in whole or in part by the negligence of the “Releasee” or otherwise including negligent rescue operations; and I further agree that if, despite this release/waiver of liability and assumption of risk, I or anyone on my behalf makes a claim against any of the aforementioned, I will indemnify, save and hold harmless each of the “Releasees” from any loss, liability, damage or cost which may incur as a result of such claim.

I acknowledge and agree that due to the inherent risk presented by COVID-19 and its variants, Partnership for a Drug-Free Community, Inc. does not in any way guarantee safety or prevention of infection. I also acknowledge and agree that Partnership for a Drug-Free Community has taken appropriate and reasonable steps to minimize the risk of COVID-19 infection and to adhere to the CDC guidelines.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT and understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
